3. This MoU constitutes the entire agreement between the parties, and all prior discussions, agreements and understandings, whether verbal or in writings are merged in this agreement.
4. This MoU is not considered to be a contract creating legal and financial relationships between the parties. Rather it is designed to facilitate and develop a genuine and mutually beneficial exchange process/ academic relationships, and so forth.
5. The MoU shall become effective as of the date of signature of both the parties. It may be amended by written consent of the parties.
6. The MoU should be reviewed every year to evaluate the progress and the quality of the mutual cooperation. It may be extended for an additional two-year period upon the written consent, then it is concluded at the end of the specified time period, or as other activities in progress have concluded.
7. The MoU may be terminated by either party with a minimum of 120 days written notice. Activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed.

NOW THEREFORE, IN CONSIDERTION OF THE COVENANTS AND MUTUAL PROMISES SET FORTH HEREIN, THE PARTIES HERETO AGREE AS FOLLOWS:

- The Post Graduate Department of Chemistry SSV College, Valayanchirangara (P.O),Perumbavoor,Kerala-683556 shall select PG students for the purpose of conducting Value added Certificate Course on “Sophisticated Instrumental Analysis”
- The selected students shall undergo 30 hours of training in the college campus and IITS training centre, which would be designed jointly by IITS and college and imparted by IITS and operationally acceptable to college. The Certificate in respect of the said course shall be awarded jointly by IITS and College.
- The College will be responsible for providing all infrastructural facilities needed to conduct the theory classes at the college.
- IITS will be responsible for conducting Practical sessions at the IITS center.
- The theory and practical training shall be conducted by IITS’s faculty members.
- To provide instrumentation facilities for students for hands-on training as part of the certificate course offered by Post Graduate Department of Chemistry, SSV College on Foundation Course in Instrumental Techniques and Chemical Analysis
- To develop curriculum of Certificate courses for the Degree and Post Graduate students of Chemistry in tune with industrial requirements.
- To permit the students and faculty of the first party for Industrial visit and involve them in industry-oriented training programmes.
- To facilitate Faculty exchange between the two institutions, the first party agrees to send their Faculty members as visiting Faculty for the certificate courses offered by the second party. The second party agrees to send Faculty for training sessions on career guidance, employability skills and soft skills.

However, the fee structure will be subject to changes for the following batches, and mutually agreed by both parties.
