II. **Roles and Responsibilities:** The Parties agree to the following roles and responsibilities.

The Hospital agrees to provide Mental health promotion services and mental health-related activities, including promotion of positive social, emotional, and behavioral skills and wellness, which are designed to meet the needs of all students regardless of whether or not they are at risk for mental health problems. These activities can be implemented for the whole college.

Mental health-related activities

- Mental health screening
- Social Emotional Learning (SEL) activities
- Positive behavioral expectations and rules/Classroom management
- Mental health literacy for students and Staff
- Progress monitoring of students identified with mental health problems and those receiving services
- Individual treatment for students with mental health problems
- Group treatment for students with mental health problems
- Family therapy to support students with mental health problems
- Psychiatric evaluation
- Teacher/staff consultation for students identified with mental health problems and those receiving services
- Family peer support/navigation support services for families of students identified with mental health problems and those receiving services.

Ensure the complete confidentiality of any and all identifying student and family information

gathered in the performance of this agreement. The information gathered, used and developed shall not be provided to any other party without the express written



approval of the individual(s) authorized to give consent for release of information.

Meet Central, state and local regulations required of mental health providers.

SSV College agrees to coordinate with doctors of second party and follow their advice, however the choice of hospitalization and right to choose treatments will still lie with the employees and students of the college.

Duration and Termination:

This Agreement is for the period from Sixth day of September 2022 to Fifth day of September 2025. Either party may terminate this Agreement for non-performance after first giving written notice of breach to the other party and an opportunity for the other party to cure the non-performance within fifteen (15) days of the receipt of written notice.
