PROGRAMME REPORT

The seminar on Legal and Ethical Steps for Startups was conducted on 30-08-2022. Smt. Sumi K.S, Innovation Ambassador and Assistant Professor in Economics was the resource person for the seminar.

The session aimed to equip participants with a deep understanding of the legal and regulatory landscape, emphasizing the significance of ethical considerations in establishing and running a successful business. The session commenced with an in-depth exploration of legal and permit requirements that startups need to navigate. The resource person discussed the intricacies of business licenses, permits, and compliance obligations at local, national, and international levels.

The session on legal and ethical steps covered all the legal and permit issues, data protection and privacy issues, protection of IPR, tortious liabilities and the ethical issues related to startups. The session covered a range of topics related to the legal and regulatory aspects that start up should comply with, importance of intellectual property rights in protecting their ideas or innovations etc.

The resource person provided a comprehensive overview of different types of intellectual property, such as patents, trademarks, and copyrights, and outlined strategies for startups to protect their intellectual assets. The resource person has stressed on the importance of having a culture of ethics while setting up own business.

The liability of a startup in compliance with legal implications was also discussed. The concluding part of the session focused on the liability of startups concerning legal implications. Participants gained insights into potential legal challenges and were provided with a roadmap for ensuring compliance from the inception of their ventures.




Figure 1 Screenshots of the seminar
